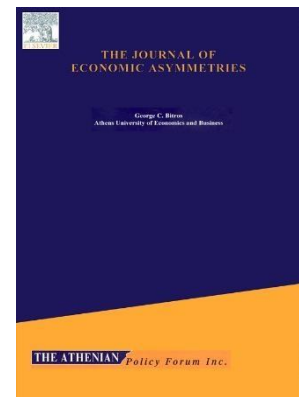
Associate Professor Ambrus Kecskés, *Associate Professor of Finance at the Schulich School of Business, York University, Canada.*
